- 1) Nominees must have permanent employment or be self-employed
- 2) Nominees must be a permanent resident of, or work in the Greater Moncton area for the past 2 years
- 3) Nominations are open to BPW Greater Moncton members and non-members
- 4) You may nominate a women from the community OR Nominees can submit nominations on their own behalf
- 5) Completed web application forms must be received by **February 18, 2019**.

Judging Criteria:

The 2019 Phenomenal Women Award recipient will embody these characteristics:

- Vision and Leadership
- Positive Role Model
- Community Service
- Alignment with BPW values and mandate

The BPW mandate is to improve the economic, political, employment and social conditions for women.
